RIBBON CUTTING SET FOR \$2 MILLION FUEL PIER PROJECT

The Port Authority of Guam, along with N.C. Macario and Associates, Duenas and Bordallo Consulting Engineers, Dick Pacific and Shell Guam, will be cutting the ribbon on the F-1 Fuel Pier Upgrade project at Cabras Island at 10:00 a.m. on Thursday, September 7, 2006.

N.C. Macario was the Architectural Engineer for the project. Duenas and Bordallo, along with the Port's Engineering Division and Shell's Engineering Division provided construction management for the project. The contractor was Dick Pacific.

The scope of work included the repair of five breasting dolphins of the fuel pier that were damaged in the October 2001 earthquake, as well as an upgrade of the main wharf and concrete ramp. New fenders were also installed on four of the dolphins.

As one of only two fuel piers serving the entire island, and serving as a transshipment point for fuel for the rest of the Marianas and Micronesia, the pier is critical to the continued growth of the economy of Guam.
