A hard copy or CD of the Invitation for Bid (IFB-PAG-CIP-018-004) may be picked up at the Port's Procurement Office on the 2<sup>nd</sup> floor of the Administration Building for a \$25.00 fee. All interested bidders must completely fill out the bidder's register and pay fees prior to receiving any copies.
