French pilot says he was tied to firing target in hazing ritual

(Reuters) - A French air force pilot has filed a criminal complaint alleging that as part of a hazing ritual he was tied to a target on a firing range while fighter planes flew overhead and fired off munitions, his lawyer told Reuters on Saturday.

The complaint did not identify any of the people alleged to have carried out the hazing, or say how many of them were involved. Reuters was not able to independently establish the identities of those responsible for the incident.

Colonel Stephane Spet, a spokesman for the French air force, said an internal inquiry had been ordered by air force command and those responsible had been punished.

The most severe punishment was restriction to barracks, Spet said. He did not say how many people had received this punishment, or for how many days.

Spet said that the pilot's safety was never in danger.

The pilot said in the complaint, which was seen by Reuters, that the hazing occurred in March 2019, soon after he arrived at a combat fighter unit at the Solenzara air base on the French Mediterranean island of Corsica.

The pilot had a hood put over his head, and was forced into the back of a pick-up truck by several colleagues who drove him to the firing range, according to the complaint.

Photos, which were included in the complaint, showed a man in military fatigues with his legs and hands bound, attached to the firing range target with heavy-duty nylon straps.

Video footage, which is cited in the complaint and was provided to Reuters by the pilot's lawyer, Frederic Berna. also showed combat jets making several low passes nearby.

The complaint alleges that, during some of these passes, the pilot tied to the target could hear the sound of live munitions being fired from the aircraft.

Spet did not dispute the authenticity of the images, but he said they created the mistaken impression that the aircraft were directing fire at the pilot who was tied to the target.

He said that the firing the pilot heard was from aircraft that were on a training exercise at a different location, and that the closest any munition round came to him was about 0.6 miles.

Berna said his client did not want his name disclosed publicly because of privacy concerns. Reuters has seen the pilot's name in the complaint.

Berna said the photos and video footage cited in the complaint were filmed by service members who were present, and the images later shared in a WhatsApp group chat. Members of the group chat then shared the images

Asked why his client waited until now to file the complaint, Berna said the pilot had initially been in denial about the gravity of what he experienced, and did not want to challenge the military authorities.

Australia's most populous state extends **COVID** restrictions in hunt for outbreak source

Australia's most populous state recorded no new COVID-19 infections for a third straight day on Sunday but extended raised social distancing and mask-wearing rules by a week as the authorities hunted for the source of a small outbreak.

After a Sydney couple tested positive to the coronavirus last week, ending a long run without community transmission, the authorities reinstated some social distancing measures until May 10, and a campaign to get more people tested, as they scrambled to determine the source of infection.

On Sunday, the authorities reported a third straight day without a new case, easing concerns about a wider outbreak in the city, but cited the mystery cause of infection as a reason for extending the measures.

"As the 'missing link' case hasn't been identified we're keen to prevent a super-spreading event," said New South Wales state premier Gladys Bereiiklian in a tweet.

"All safeguards/restrictions will be in place for an extra week, except for shoppers in retail who will no longer

be required to wear a mask."

That means the more than five million people living in and around Sydney must wear masks on public transport and in most public venues, while households are limited to 20 guests at any one time until May 17.

Australia has largely eliminated the virus, with 79 days in 2021 without a locally acquired case, according to the government, as a result of a strategy of closing international and domestic borders, as well as social distancing measures.

As the country awaits vaccine ship-

ments and watches infection spikes in other countries, top lawmakers have said borders now appear likely to reopen in 2022, not 2021 as previously envisaged.

In an interview with News Corp newspapers published on Sunday, Prime Minister Scott Morrison said it was unlikely Australia would reopen its borders soon, although he did not offer a timeline.

"I don't see an appetite for that at the moment," he said, referring to border reopening.

"What we're seeing at the moment is the appreciation of the people that the pandemic isn't going anywhere. We have to be careful not to exchange that way of life for what everyone else has.
